# Terms and Conditions

## Fee Payment

The member subscription fee must be paid upon registering for Futuwwa. Casual members do not need to pay the Futuwwa fee. The Full Member fee can be made in one payment or in seven payments (via Standing Order). Monthly fees (for casual members) must be paid in full at the beginning of the month. Session fees should be paid at the start of the lesson.

## Fees

The member subscription fee for joining Futuwwa, for both Full and Casual Members, is **£50**. There is a 40% discount for 2014-15. The fee for a Full Member is **£700**. A description of the monthly/session fees (for each activity) along with individual session fees is available upon request.

## Membership Information

Full Members are entitled to attend any session of any activity throughout the year. The annual fee (for full members) will cover seven months for 2014-15. Casual members can either attend sessions on a monthly basis or as and when they want. A member's subscription for Futuwwa will need to be renewed every year.

## Cancellation and Refunds

Member subscription fees are **non-refundable**.

### Annual Subscription Fee (for Full Members)

Should you cancel your full member subscription, you shall forfeit some or all of your payment, depending on the date of such cancellation, as follows:

1. Notification received by the end of **Week One** of the Full Member subscription: The annual fee will be refunded.
2. Notification received by the end of **Week Four** of the Full Member subscription: You will owe **50%** of the annual fee.
3. Notification received after **Week Five** of the Full Member subscription: **There are no refunds**. The full annual fee must be paid.

### Monthly Session Fees

Should you cancel your fee for a month, you shall forfeit some or all of your payment, depending on the date of such cancellation, as follows:

1. Notification received before the start of the month: The course fee will be refunded.
2. Notification received by the end of **Week Two** of the month: You will owe **50%** of the monthly fee.
3. Notification received after **Week Two** of the course: **There are no refunds**.

### **Limitation of Liability**

Greensville Trust shall not be responsible for any loss or injury obtained when attending any of the Futuwwa courses or activities. By signing this agreement, you agree that you, your heirs, legal representatives, or any member of your family will not make a legal claim against or sue Greensville Trust for its work in managing and administering Futuwwa Sports. If any portion of this agreement is unenforceable, the remaining portions shall remain in full force and effect. This agreement shall be construed, enforced, and governed according to the laws of England and applicable to agreements made and to be performed in the United Kingdom.
